OPEN TENDER

Construction of Perimeter Wall for Kibo Seed Company Tender No. KSCL/TEND/CONSTR/01/2025-2026.

Dear Sir/Madam,

We kindly request you to submit your TENDER for the *Construction of Perimeter Wall for Kibo Seed Company (KSCL/TEND/CONSTR/01/2025-2026)*.

TERMS OF REFERENCE (TOR).

1. BACKGROUND

Kibo Seed Company is a private Company registered in the United Republic of Tanzania in the agricultural industry and in the Seed Sub sector. The main activities for the Company are carrying out Research, production, processing of seed, sales and marketing activities of seed and other complimentary products.

The Company invites sealed bids from eligible and qualified contractors for the construction of a perimeter around office building.

- i. The left side of the building (Behind production office to the corner)
(approximately 30 meters subject to confirmation)
- ii. From the corner to the left side of the gate (approximately 93 meters subject to confirmation)
- iii. From the right side KSCL gate to neighbor's wall (approximately 19 meters subject to confirmation)

TOTAL 142 METERS (Subject to confirmation)

The purpose is to enhance privacy and security by restricting visibility from neighboring plots.

2. SCOPE OF AN WORK

The selected contractor shall:

- a) Clear the trees and vegetation and prepare the site
- b) Supply all necessary materials.
- c) Construct a secure, durable perimeter wall. This is the Masonry/block wall with anti-climb finish of razor wire topping
- d) Ensure proper finishing including internal and external plastering
- e) Comply with all relevant construction and safety regulations where by minimum height will be 2.3 meters all round with razor wire topping, wall type will be blocking wall with concrete pillars every 2.5 meters (apart from the 20 meters at the corner)
- f) 20 meters of the wall at the corner towards Okaseni (10 meters each side) will require additional reinforcement of blocks to mitigate against any flood water pressure (as done by the neighbors). The 20 meters should also have concrete pillar every 2 meters
- g) The depth of the wall's foundation should not be less than 1.2 meters all round

3. SITE VISIT

Interested bidders are encouraged to visit the site before bidding.

4. ELIGIBILITY CRITERIA

The bids will be evaluated based on the mandatory, technical and financial capability of the firm. Only responsive bids will progress to the next level of evaluation while non responsive bids will be dropped at the level of non-responsiveness. The pass mark for the technical evaluation will be 50%.

The lowest evaluated bids will be awarded the contract upon being responsive in the other levels of evaluation.

a) MANDATORY REQUIREMENT

The Service Provider **MUST** submit the following mandatory documents:

- i. **Company profile** – Provide a brief of the company including the business address and contacts.
- b) Copy of TIN certificate with ability to provide EFD receipts for the work.
- c) **TECHNICAL REQUIREMENTS (70%)**
 - i. **The Firms general experience, reputation in previous similar assignments**
 - **Number of years the firm has been doing this assignment**
 - 1-5 years – **Marks (10%)**
 - Attach (3) three recommendation letters from the previous companies for undertaking similar services as required by KSCL, indicating description of contract scope, contract duration, contract value, contact references; - **Marks**

- ii. **Understanding of the terms of reference, methodology and timeline for delivery of the work-** Attach or document the methodology to be used as well as the work plan indicating the timeline within which work will be completed and the warranty (30%).
- iii. **Qualification of key personnels;** - Provide evidence of qualification and experience of two key personnel who will be involved in this assignment. (20%). Each personnel will get 10% Marks.

d) FINANCIAL EVALUATION

The bids responsive at both the mandatory and technical evaluation will be subjected to financial evaluation whereby the lowest bids will be awarded the tender.

NOTE:

The tender documents should be prepared in English or Swahili and the quotation should be in Tanzania shillings currency.

5. SUBMISSION INSTRUCTIONS

Proposal **MUST** be submitted physically to our offices KIBO SEED COMPANY LIMITED located at Okaseni Street off Arusha – Namanga Road Opposite Dodoma/East Africa By-Pass Road Junction Also, Opposite Petro Africa Ngaramtoni Service Station Arusha, Tanzania.

Quotation must be submitted on or before **20th October 2025** not later than **10:00am** in the tender. The opening will be done immediately and representatives are invited to attend.
